



27th Annual Recognition Day

On Thursday, October 18th, 2007, in front of a near-full house in the Los Angeles Convention Center, 357 LAPD sworn and civilian employees, former employees, City employees from other Departments, and volunteer citizens were honored at the Department's 27th Annual Recognition Day Awards Ceremony. Recognition Day is a Department tradition wherein deserving individuals are saluted for their outstanding heroism, dedication, and commitment to service.

The ceremony featured all the grandeur one would expect from an event of such magnitude: the entrance of the Color Guard and the pledge of allegiance, the National Anthem performed by a young vocalist from the community, and the presentation of each medal by Chief of Police William Bratton. City leaders and community members joined the Department command staff, family, friends and coworkers for the event.

Chief's Message ... William J. Bratton, Chief of Police

Last month I focused my message on the many positive changes that have occurred here at the Los Angeles Police Department over the past five years. As I begin my second term as Chief of Police, it's an appropriate time to talk about a number of additional initiatives. They represent more of our efforts to achieve best practices, and I believe they are further evidence of our commitment to one of the Department's Core Values: Quality Through Continuous Improvement.

Throughout my 37-year career, I have always dealt with adversity and controversial issues and incidents forthrightly and transparently. I always seek to learn from both success and failure and to emerge from crisis, controversy, and challenge better informed and strengthened. As I have previously discussed with you, in reference to the events in MacArthur Park on May 1st, much of what happened that day was inconsistent

with the way we normally perform our duties and responsibilities. But even though it was a setback for us as a proud Department, confident of our skills, reputation and capabilities, we have learned some very valuable lessons. We must embrace and move forward with the lessons learned and articulated in my October 9th report to the Police Commission, that provide the framework for developing and institutionalizing "best practices" for future events. As that report so succinctly shows, training- constant, regularly updated training- as well as modern technology and comprehensive, coordinated planning, are essential elements for the successful management and control of major events. The report clearly described many of our leadership, management and individual failures during that event, and we will learn from the experience. We are a proud and exceptional organization that is also a learning organization that consistently seeks to

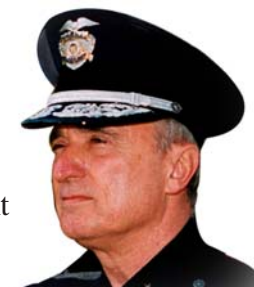
learn and create best practices. A major positive outcome from the events of May 1st is the creation of the Incident Management and Training Bureau.

INCIDENT MANAGEMENT AND TRAINING BUREAU

The Incident Management and Training Bureau (IMTB) came into being in the weeks following May 1st. The new Commanding Officer of

IMTB, Chief Mike Hillmann, and his team spent all of July conducting updated training for 4 Area stations. In August, they analyzed the information they gathered in the July sessions and refined the curriculum to make it as meaningful as possible. September saw them return to scheduled Area trainings, which will continue for all areas through spring 2008. It is then my intention to have every sworn member of the Department go through the Crowd Management and Control Training every two years.

Aside from developing and conducting the Crowd Management training curriculum, IMTB has had other projects to handle as well. In the aftermath of May 1st, they provided updated training to the entire Metro Division, sought out and trained more instructors to work the Area training sessions, and put long hours into the preparation of the Department's MacArthur Park after-action report. In August, ITMB, together with Hollywood Area and West Bureau, worked with the Los Angeles Fire Department in a first time ever practice evacuation of homes in a 1-square mile area near Griffith Park in response to the fires that affected this community last May. Emergency preparedness being a priority for all public safety organizations, members of ITMB also went to Minneapolis to meet with officials and study their response to the devastating bridge collapse they faced last August.

Strict and demanding criteria governs the awarding of these medals and commendations. Selected candidates must have distinguished themselves by acts of bravery, heroism, service, or by significant achievements above and beyond normal demands of duty. The Awards presented on this day included: 21 Police Medals and 76 Police Stars- the Department's two highest awards for bravery after the Medal of Valor- as well as 23 Life Saving Medals, 28 Community Policing Medals, 4 Human Relations Medals, 175 Police Meritorious Unit Citations, and 34 Police Commission Distinguished Service Medals, in various combinations.

In an emotional segment of the ceremony, Officer Kristina Ripatti presented Life Saving Medals to the five officers who saved her life after a fateful encounter with a robbery suspect on June 30, 2006. Officer Ripatti addressed the crowd and expressed her appreciation for being

alive to be there that day, and to continue to be a mother to her daughter. In a surprise announcement, she also shared the good news that she and her husband are currently expecting another child.

At a separate presentation on Tuesday, November 6, 2007, during the weekly meeting of the Board of Police Commissioners, 5 more medals were awarded, including 2 Police Commission Distinguished Service Medals, 1 Police Meritorious Service Medal and 2 Police Distinguished Service Medals. On this day, City Attorney Rocky Delgadillo was present for awards to two Deputy City Attorneys.

Guests in attendance at both the Convention Center and the Police Commission presentations heard the compelling and inspirational stories that lead to the esteemed honors.

The Department extends sincere congratulations and profound gratitude to all recipients. □

Eighth Annual True Blue Goes Hollywood

The Los Angeles Police Foundation (LAPF) kicked it up a notch at this year's True Blue event, pulling out all the stops for a glamorous outdoor party on the Paramount studio lot in Hollywood. In the "New York Street" area of the backlot, party-goers and supporters joined dignitaries including Mayor Antonio Villagraigosa, Chief Bratton, LAPF President Karen Wagener, Police Commissioners, command staff, and officers to rub elbows with Hollywood mega-producer and honoree Brian Grazer (24, *The Da Vinci Code*, *A Beautiful Mind*), actor Albert Brooks (*Broadcast News*, *Mother*), and Jim Wiatt, William Morris Agency CEO and LAPF Chairman.

The street party-style event featured live music and dancing, gourmet

dinner buffets as well as on-site catering by In-N-Out Burger and Pink's Hot Dogs, wine tasting and more than 100 silent and live auction items. Unique auction items this year included a one-of-a-kind piece from Phillip Press Jeweler, two first class tickets to Europe, and a flight on a Russian MIG fighter jet.

Guests had the unique opportunities of testing their skills on the LAPD Force Options Simulator as

well as taking a spin on one of the new T-3 Personal Mobile Units. The LAPD SWAT Team, detectives from the Cold Case Unit, and criminalists from Scientific Investigation Division were among the more than 30 specialized units who showcased their equipment and mingled with guests.

During the event, the Foundation paid tribute to ten men and women of the Los Angeles Police Department who were presented with the Crystal

Angel Award for outstanding community service both on and off duty. Additionally, for the first time in the history of the event, the Guardian Angel Award was bestowed for outstanding duty performance.

With nearly 1000 guests in attendance and raising a net of \$1 million dollars, the Eighth Annual True Blue event was a smashing success. The

Clearly this new Bureau has become highly productive in a very short period of time and we have the May Day march to thank for its creation. That is positive response defined, and in the weeks, months, and years to come, we will all benefit from this positive outcome of the May Day events.

TEAMS II

I am also pleased to report that over the past several months, the Department has made significant progress in the implementation of

TEAMS II, the major component of the Consent Decree. Department-wide deployment of the new Complaint Management System was completed in April 2007. Additionally, the TEAMS II Development Bureau made significant improvements to the Use of Force System, simplifying the processing of categorical uses of force within the system, making the experience more efficient for users. TEAMS II personnel will continue to work with all of you to make the system more user-friendly.

Risk Management Information System (RMIS) Action Items were deployed Department-wide in March 2007. As of September 21, 2007, 1688 action items had been issued and 1222 had been completed and approved through the Bureau level. Because RMIS has gradually become the Department's data repository, TEAMS II staff have been developing an ad-hoc reporting tool to take advantage of the available data and develop meaningful analytical reports.

In January 2007, the Independent Monitor for the Federal Consent Decree began its review of the TEAMS II system. To date, the Monitor has found 10 of the 15 TEAMS II-related paragraphs to be in compliance with Consent Decree requirements. The remaining five paragraphs are still under review by the Monitor and will be evaluated in the next Monitor Quarterly Report. We anticipate at this time that we will be in

full compliance with all 15 paragraphs, a major milestone and one that is essential to allowing us to come out from under the Consent Decree. Out of the negative of the Rampart problems has come- not without a lot of hard work- state of the art, best practices management and personnel accountability systems that will be more fair, more timely, and consistent throughout the Department.

BOUNCE

The Recall Program, nicknamed "Bounce," was approved by City Council on September 14, 2007. Bounce extends the DROP Program's end date, allowing sworn personnel to be hired back by the Department after retirement for a period of up to twelve months, as needed. The Department will bring back only those employees that are deemed necessary for critical

Chief Bratton Takes A Walk On Skid Row

On Wednesday, October 3, 2007, Chief Bratton joined Councilmember Jan Perry, Commander Andy Smith, community leaders, volunteers and several Cental Area officers in the monthly Skid Row Neighborhood Watch Walk. The walk is the result of a collaborative effort between Councilmember Perry, LAPD, the Central City East Association (CCEA,) Skid Row residents, state and county legislators, service providers and many others seeking to affect positive quality of life changes in the area.

The nearly mile-long walk led the group around several of the worst parts of Skid Row, which for decades has struggled with homelessness, drug abuse, prostitution, and crime. During the walk, outreach efforts to those living on the streets were conducted. Representatives from the Los Angeles Homeless Services Authority were present, offering transportation to

LAPD Officer Receives Purple Heart

Officer Brent Williams was presented with the Purple Heart Medal on Monday, September 24, 2007, in the Tom Bradley Room of City Hall. Officer Williams served in Iraq in the summer of 2004 and was injured in a rocket attack. He suffered shrapnel wounds and sustained damage to his hearing as a result of the incident. Officer Williams was honored by Mayor Antonio Villaraigosa; Assistant Chief James McDonnell; Bill Hutton, State Commander, Military Order of the Purple Heart; and General John Harrel, Commander of the 40th Infantry Division, Joint Forces Training Base, as

family, friends and colleagues looked on.

Some 500 Department employees are involved in either the National Guard or the armed forces reserves. Currently there are approximately 40 LAPD employees – both sworn and civilian – on long-term military duty. □

selective assignments. In this process, it is possible that an officer may be recalled to a vacant position. In this case, we have committed to the League that recalling officers will not adversely impact promotional opportunities for active officers. Bounce is a temporary, one year only, extension, after DROP.

MOBILE RADIOS

I have continuously mentioned that having the best equipment is equally as

important as best practices. In this regard, mobile radios are critical to the job you do, and to keeping you safe. We are continuing the installation of the new Motorola XTS 5000 mobile radios in selected unmarked vehicles and in all new black and whites. To date, 750 have been installed. As cars come in for service, they will have their radios replaced, with the exception of cars whose odometers bear 90,000 miles or more. Additionally, we are expecting 590 new cars to replace

salvage cars in the 1st quarter of next year and each of these cars will receive mobile radios as well. The Department goal is for all cars to have the new mobile radios by the end of next calendar year. The Motorola XTS 5000 meets the Department of Homeland Security guideline that all new radio purchases be compliant with Associated Public Safety Communications Officials Project 25 (APCO P25) standards. P25

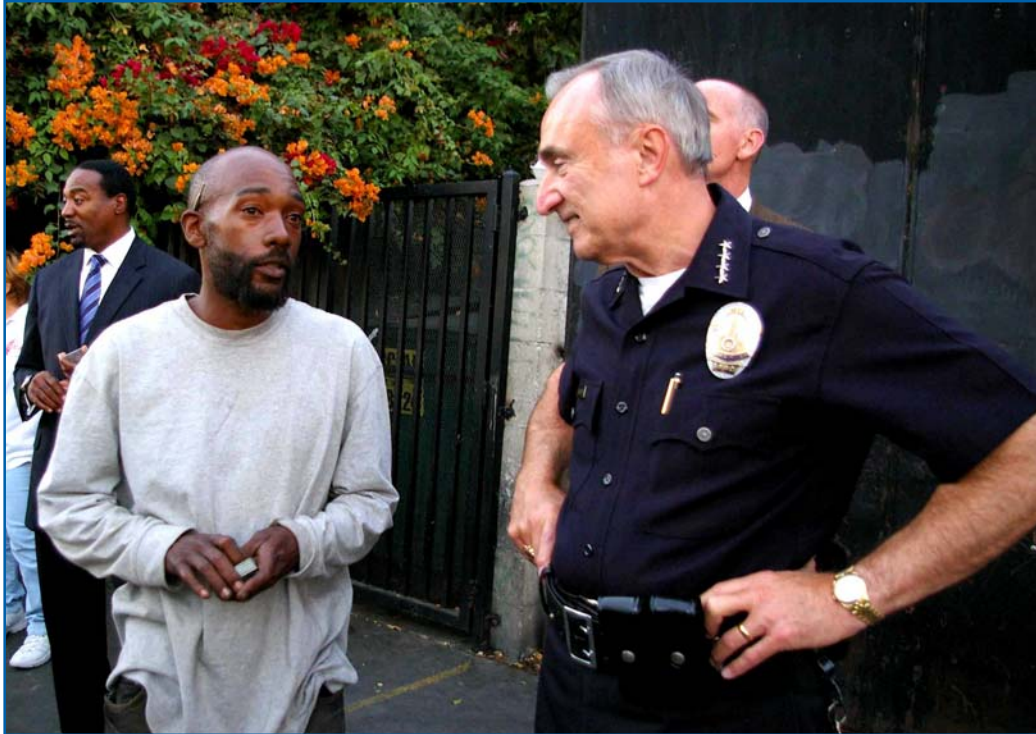
shelter and services for any homeless individuals who were interested.

The goal of the walk is to let the many men, women and children living on Skid Row know the community is

committed to help, and also to warn drug dealers and other criminals their activities won't be tolerated. The walk represents a caring community in the process of reclaiming its streets and

also typifies community policing at its best. The Skid Row walk is a visible example of strong relations between LAPD and the community, and in over two years of the monthly walks, changes have become visible.

In September 2006, the Department launched the Safer Cities Initiative, backed by Mayor Antonio Villaraigosa, Councilmembers Perry and Jose Huizar. Safer Cities effectively added 50 officers to patrol Central Area, and Skid Row, in particular. One year after its inception, the Initiative had yielded a drop of over 26% in total Part 1 crimes in the Area. □

compliance means these radios are capable of supporting inter-agency communication in the event of a widespread, grand scale emergency. We will also be continuing our efforts with the City Council to get funding authority to replace our now seriously outdated portable radios.

Buildings Update

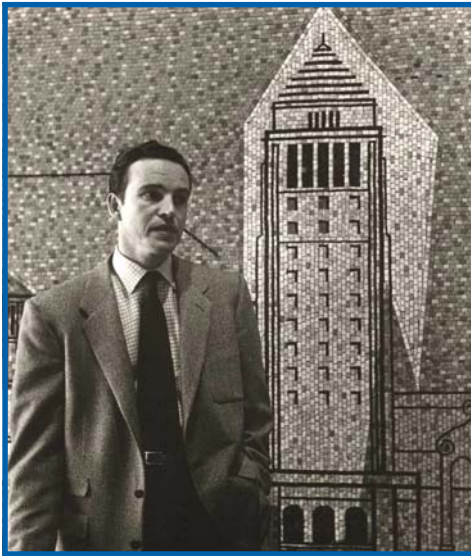
Metro Bomb Squad, Valley Bureau/Valley Traffic Division and Rampart Area facilities have now passed the 90% completion mark, with move-in projected for next year in February, March and July respectively. The Mid-City station is currently 80%

complete, and Harbor, Hollenbeck and Northwest Valley stations are all about three-quarters of the way complete, along with EOC/DOC/Fire Dispatch. The new jail facility is 60% complete while our replacement headquarters is at 25%. In 2008 and 2009, there will be many building dedications and move-in celebrations, finally giving our first class Department first class facilities.

In closing, thirty-seven years ago, I became a cop. I have never regretted that decision. As you all know so well, there is no other occupation or profession that allows you to have a life of such significance and impact.

Everything that you do counts-cops count. As we perform our duties, we will make mistakes. We will work with the limited resources available to us. We will work in the face of adversity and criticism. But when all is said and done, I am confident that as Los Angeles Police Officers, we will be able to say, "We made the difference." Thank you for the opportunity to work with some of the best cops in America in a Department second to none, the LAPD, making a difference in our Department, our profession, our city, and our country. You are creating change by becoming the change. □

Joseph Young 1919-2007

The Department is mourning the loss of a valued friend. The creator of the colorful mosaic tile mural in the lobby of Parker Center, artist Joseph Young, died Saturday, August 25, 2007, of pneumonia, at age 87. In creating the mural, Young created one of the building's- and the Department's- most enduring images. Employees and visitors alike have passed the historically important work of art entering and exiting the building for more than 50 years.

Joseph Young was born in Pittsburgh on November 27, 1919. After studying journalism in New York City, he began a 3-year stint in the Air Force in 1943. Upon discharge, he studied mural art for six years in Europe and Mexico before settling in Los Angeles in 1952. He was two years into his Los Angeles career when, at age 34, he was commissioned by the City to create the Parker Center mural, *Architectural History of Los Angeles*.

Governor Awards Medal Of Valor To Two LAPD Officers

Governor Schwarzenegger awarded the Public Safety Officer Medal of Valor to LAPD Officers Mark Mireles and Edwin Marron, and LAFD Firefighter Paul Schori, on Tuesday, September 25, 2007, in the Council Room of the Office of the Governor at the State Capitol in Sacramento, CA.

On January 5, 2006, Officers Mireles and Marron, and Firefighter Schori, responded to an attempted suicide call. The officers approached a woman attempting to commit suicide off of the 6th floor balcony of an office building. As she rolled off the edge of the balcony, Officer Mireles caught her by the leg and she tried to fight him off. Losing the struggle, Officer Mireles called to his partner, Officer Marron, who grabbed his leg. Firefighter Schori

then arrived and secured Officer Mireles' belt, pulling the two officers and the woman to safety.

Said Governor Schwarzenegger, "We owe a debt of gratitude to our public safety officials for their selfless commitment to serve in the line of duty, risking their lives every day to protect Californians. These men showed extraordinary valor and courage, going above and beyond the call

of duty, to protect their fellow Californians and preserve public safety. This is highest public safety award offered by our state and their courageous actions are truly deserving of the honor."

Officers Mireles and Marron were also awarded with LAPD Medals of Valor in a ceremony on May 10, 2007.

The 6-ton, 36' x 6' mural made history at the time for being the world's largest glass mosaic mural ever executed by an American artist. The piece was also the first major work of its type to depart from conventional installation in a wall or floor, instead using the support columns of the building itself to "hang in space." The

mural originally served as a partition between the lobby and the public phone area, which today is a security checkpoint. The mural is comprised of 250,000 hand cut glass tiles, in more than 50 colors, each of which was set by hand over the two years Young worked on the piece.

An in-demand artist who has been characterized as ahead of his time, Young went on to create other well-known public art pieces in Los Angeles and throughout the Southland.



Among some of his other familiar local works are the mural in the Hollenbeck station;

Topographical Map, the mural on the north face of the Hall of Records on Temple Street;

and perhaps his most famous and controversial work, the *Triforium*, a sculpture of concrete, glass, and lightbulbs prominently positioned on the corner of Temple and Main streets at the Los Angeles Mall.

Young is survived by his wife Millicent, his daughters Cecily and Leslie, and three grandchildren. □
