



2007 WOMEN'S LEADERSHIP CONFERENCE BREAKS RECORDS

In what has become one of the most highly anticipated yearly events, the 2007 Women's Leadership Conference broke attendance records. On October 24, 2007, more than 1,000 attendees, including male sworn and civilian employees, packed the Hilton Los Angeles Universal City Hotel. The event was in such high demand that there was a waiting list of more than 400.

The mission of the Women's Leadership Conference is "to develop the leadership skills of women, as we impart knowledge through vision, enhance their promotability and empower them to be successful in various aspects of their lives." In her welcoming remarks, Assistant Chief Sharon Papa said, "If you are not ready to become a leader but recognize someone who can be, encourage them to do so."

This year's theme, "Leadership Through Vision," was the thread of continuity among the guest speakers who tasked all women with the responsibility of counseling,

mentoring, and leading. Featured speakers included members from within the Department and from law enforcement agencies from across the United States and even as far away as Ireland. Panelists were accomplished, recognized in their field, and explained the different things that built the foundation in their careers: a great mentor, education, hard work, and family support. Each speaker also touched upon the obstacles they encountered in their path to reaching their objectives and how they maintained a balance between their careers and family lives.

Featured speaker Deidre Bones, Chief Inspector, Police Service of Northern Ireland, thought it was appropriate for the Women's Leadership Conference to be held in Los Angeles, the city that hired the first female police officer in the country.

Chief's Message ... William J. Bratton, Chief of Police



With the holidays upon us, and the year near its end, it is appropriate to pause for a moment to reflect on the experiences of the past year. The year 2007 has been a good one for the Los Angeles Police Department, and for the people of the City of Los Angeles. We have much to be thankful for and now is the time to count our blessings.

First and foremost, crime in our city is down. You've heard me say it before, it is *the story to tell here.* Crime levels

in Los Angeles are down dramatically- for the fifth year in a row. This is due, in no small part, to you and your non-stop efforts. Only pure talent, sheer determination and consummate professionalism can deliver the sort of results we have seen here in Los Angeles. We are a historically understaffed Department charged with policing a sprawling city- a city that was once

For me that future begins with my second term as your Chief. I am grateful to the members of the Los Angeles Police Commission for

I intend to continue to focus on the goals I established when I became your Chief in 2002: continuing the yearly reductions in crime, fully implementing the consent decree, building a renowned Counter Terrorism prevention Bureau, increasing the size of the LAPD and procuring for you the very best technology and tools avail-

in assaults on officers we've seen this year. Success against such odds makes this good news even better. I want to commend each of you for working so hard and successfully reducing crime in our city, all the while knowing of the ominous statistics at play. Bravery and courage are essential to the success of any police officer, and I am privileged to see so much of it in the officers of this Department.

Speaking of bravery and courage, this year, 16 Department employees- 15 sworn and 1 civilian- will be overseas on military duty for the holidays, away from their families and friends. This level of service is the epitome of the holiday spirit. Please join me in saluting each and every one of them and please take time to remember their loved ones during this holiday season as well.

Another salute goes to the Marine Corps-Law Enforcement Foundation (MC-LEF), an organization that, with one overwhelmingly generous act, has just helped change the lives of the members of the Selleh family. As we all remember, Mission Area Narcotics Detective Mike Selleh was involved in a fatal off-duty motorcycle accident on the 101 Freeway last July. The MC-LEF has just gifted his two children, Scott and Jessica, each with full college scholarships. These scholarships are without limit, and will cover the entirety of their undergraduate, and any post-graduate, studies. With this single act of generosity, the Selleh family will

During the conference, Lt. Gina Sanders, 77th Area, was awarded the "Woman of the Year" by the Los Angeles Women Police Officers and Associates.

The conference closed on a high emotional note with the last presentation of the day, "Officer Down," which featured retired Police Officer Kristina Ripatti, Southwest Area, her husband, Officer Timothy Pearce, Southwest Area, and Ripatti's former patrol partner, Officer Joe Meyer, 77th Street Area. They talked about their experiences this past year, including the series of events that led to the devastating shooting on June 3, 2006, that left Officer Ripatti paralyzed from the sternum down. They received

roaring applause when Officer Ripatti showed ultrasound pictures, announcing she is pregnant with her second child.

The effects of this annual conference have already been felt within the

Department. Chief Papa stated that this year saw the highest number of female applicants to Motors, a direct correlation attributed to last year's female motor officer who was a featured speaker.

The Department currently ranks fourth in the nation with 18.6% of its force being female sworn officers. Detroit Police Department, which has a female chief of police, ranks

first with 27%, followed by Philadelphia with 25%, and Chicago coming in third with 20%.

Chief Bratton Named One of *Governing* Magazine's Public Officials of the Year

Chief Bratton received one of *Governing* magazine's Public Official of the Year awards on Wednesday, November 7, 2007, at a private dinner ceremony hosted by the magazine in Washington, D.C. Chief Bratton is one of nine officials to be awarded, and is only the second police chief ever to be recognized in the history of the magazine.

The Public Official of the Year awards are given in recognition of outstanding achievement at the state and local levels. This year's group of recipients is the fourteenth to be honored in the magazine's annual awards program. *Governing* magazine is an independent national magazine devoted to the coverage of state and local governments. It was launched in 1987 and has a monthly circulation of 85,000.

Said *Governing* executive editor Alan Ehrenhalt, "These individuals have each changed their governments for the better. They have provided their organizations with something that was

desperately needed—be it fiscal discipline, managerial skill or a commitment to bipartisan conciliation—and in doing so have improved the lives of their citizens. Public officials across the country can learn from their outstanding examples."

In addition to Chief Bratton, the other recipients of *Governing* magazine's 2007 Public Officials of the Year are Washington Governor Christine O. Gregoire; Houston Mayor Bill White; California Assembly Speaker Fabian Núñez; chief financial officer of Washington, D.C. Natwar M. Gandhi; Bill Leighty, a top civil servant in Virginia for two decades; Charlotte, North Carolina planning director Debra D. Campbell; Missouri's

deputy chief information officer for operations Bill Bott; and Wisconsin Bureau of Assisted Living director Kevin Coughlin. □

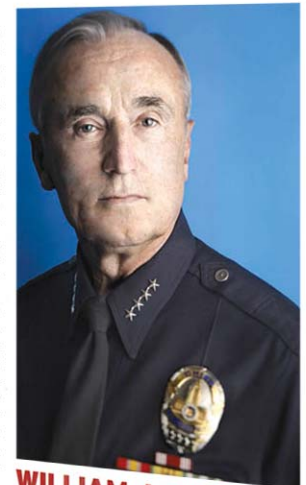

FOR BILL BRATTON, TAKING RISKS COMES NATURALLY.

Just how natural became apparent one day in 1975 when Bratton, a rookie sergeant with the Boston Police Department, got a call that would have made a veteran blanch: bank holdup; shot fired; possible hostage situation. En route to the scene, Bratton encountered the gunman—a 6' 2" man in a red leisure suit dragging a

woman across a bridge, away from agitated bystanders. Bratton parked and advanced through the crowd—and suddenly found himself standing five yards from the gunman, weapon drawn. At that point, Bratton violated the first rule of hostage negotiations (never give up your cover): He lowered his firearm and, looking into the barrel of the other man's gun, asked the robber to put down his gun, too. He did, and Bratton had a new reputation as someone who was either very brave—or very foolhardy.

In 1993, Bratton took an even bigger gamble. Just one year earlier, he had achieved his life-long ambition of heading the Boston Police Department after leading impressive turnaround efforts at Boston and New York's transit agencies and at Massachusetts's Metropolitan Police. But when advisers to New York City Mayor-elect Rudolph Giuliani approached him about applying for the biggest job in policing—commissioner of the New York Police Department—Bratton went after it with a plan he promised would reduce crime in New York City by 40 percent in three years time. Most criminologists considered it a crazy idea—undoable, career suicide. Giuliani gave him the job.

A non-profit organization, they receive funding from private donations and every single dollar they receive in donation goes right back out in the form of a gift. The Department extends sincere gratitude to the MC-LEF for this gracious act and all the good work they do, and we send our love and support to the Selleh family this season,

as we will every season. The gifts of education, and the close relationship between the military and law enforcement communities, are both priceless.

An annual tradition, the Toy and Book Drive underscores the very best aspect of the holiday experience: giving. AUTISM ROLL CALL TRAINING

Flashing lights and loud sirens are offsetting for many of us. However, for people with autism, it can be downright debilitating. The caring touch of another person can be calming, particularly in stressful circumstances. Not necessarily true for someone with autism. What is an officer to do when confronted with someone who is rocking or flapping or not making eye contact? How are officers to handcuff someone, for public safety, who may have autism? What is the best way for officers to protect the public, themselves, and demonstrate compassion for those on the autism spectrum? The Los Angeles Police Department is demonstrating best practices by providing training for its officers for these types of circumstances. LAPD has reached out to the community to gain the expertise and help of those knowledgeable about autism.

Detective Support and Vice Division (DSVD), Crisis Response Support Section (CRSS) and Mental Evaluation Unit (MEU) have begun a partnership with the Autism Society of

America (ASA) to conduct roll call training for Los Angeles Police Department officers.

The roll call training, for those of you who have not already experienced it, involves a volunteer from ASA who, along with an MEU officer, sensitizes officers regarding autism. By sharing with our officers, we enable them to approach the community with a better sense of how autistic individuals may react to certain situations and circumstances. This training will enhance officer and subject safety.

Individuals with autism often process information and interact with others in a unique manner. Being

familiar with these matters will help officers to communicate more effectively with autistic individuals. LAPD's expectation is that this will foster positive outcomes. Knowledge and training are powerful tools, which the Department is fully pursuing with this program.

Training will also be delivered to community autism support groups to explain Department policies when police are called for service and encounter a person with autism. These support groups, coupled with Department staff, will participate in outreach efforts, attending community meetings, neighborhood watch groups and other interested organizations.

I would like to thank the members of MEU, specifically Lt. II Rick Wall and Detective III Gil Escontrias, who created this program. A special thanks to Assistant Chief Jim McDonnell for his strong support. And most of all, to our colleagues in the community who are the caregivers and family members of those with autism, who have been so generous with their time and compassionate in their efforts. □

LAPD Reaches Out to Asian and Pacific Islander Community

In an unprecedented move, the Los Angeles Police Department announced its partnership with LA 18/KSCI-TV, the leading Asian language television station in the country, on the first ever Asian and Pacific Islander (API) Language Public Service Announcement Campaign. At long last, vital public safety information will now be available for Asian and Pacific Islanders in their own native language.

The campaign is designed to bridge the communication gaps with the LAPD and the API community. It consists of weekly guest appearances by Department personnel on the station's Chinese (Mandarin) program *LA 18 Evening News*, and monthly

guest appearances on the station's Filipino (Tagalog) program, *Kababayan LA*, and Vietnamese program, *Global Report News*. Each segment will feature a different topic highlighting crucial public safety issues relevant to the API community.

At its October 30, 2007, meeting, the Board of Los Angeles Police Commissioners and Chief Bratton celebrated the campaign launch by honoring LA 18/KSCI-TV for its commitment to the API community and generous donation of time and resources to the LAPD.

Commemorative certificates were

presented to LA 18's parent company AsianMedia Group CEO/Chairman Peter Mathes and LA 18 General Manager Brian Reed, as well as several staff members and on-air personalities.

Commission President Anthony Pacheco stated that through the showcasing of LAPD officers on LA 18/KSCI-TV, the campaign hopes to humanize the image of law enforcement in the API community, as well as to familiarize and assimilate new immigrants to local laws and protocol when dealing with law enforcement.

Chief Bratton conveyed the

Department's enthusiasm for working with the API community and noted the campaign is also an excellent venue for increasing recruitment among API candidates.

Mercury Insurance Group Donates \$1 Million For LAPD Recruitment

Mayor Antonio R. Villaraigosa and Chief William J. Bratton gratefully accepted a \$1 million donation from Mercury Insurance Group to aid the Los Angeles Police Department in its recruitment efforts at a news conference held on Friday, November 9, 2007, at the Elysian Park Police Academy.

The donation will be used to fund the Police Signing Bonus (PSB), an enticement used by the Department and City to compete against other law enforcement agencies in drawing new police officers. Chief Bratton stated the PSB is a "significant incentive to attract not only new members to the Los Angeles Police Department, but those who work for other agencies and decide that they want to come to the LAPD because of its increased opportunities."

Mercury's gift represents the largest monetary donation in the Department's history and will greatly aid the City in achieving the Mayor's goal of increasing the Department's workforce to 10,300 officers by the year 2010.

City Councilmember Wendy Greuel, present at the conference with Councilmember Jack Weiss and Personnel Department General Manager Margaret Whelan, challenged other corporations to join Mercury Insurance Group in giving back to the

community and contributing to the LAPD. Chief Bratton took it a step further by adding, "We cannot do it without officers. We cannot do it without the partnership of the private sector." □

On September 7, a group of 27 children visiting the Los Angeles area met with Chief William Bratton, Mrs. Bratton and First Assistant Chief Jim McDonnell in the Presidential Suite of the Sheraton Universal Hotel. The children, who are seriously ill with cancer, their attending medical representatives and local directors of the sponsoring organization, Sunshine Kids, were there to spend a very special day with the Los Angeles Police Department.

Chief Bratton personally welcomed each child and filled them in on some of the planned activities for the day. Chief Bratton then proceeded to the rooftop of the Sheraton Universal's parking garage where he greeted each of the 50 uniformed officers who were there waiting for the Sunshine Kids to arrive. It is important to mention that the majority of officers in attendance were reserve officers who had taken a day off work to support this event.

When the children arrived, the ceremonies began when WTD Sergeant Orlando Smith called the officers to attention for the Pledge of Allegiance, which was lead by a Sunshine Kid. First Assistant Chief McDonnell again welcomed all the guests and thanked all the officers, with special mention given to the reserve officers, for taking the time to be there. The Chief then asked the kids to raise their right hand as he swore them in as honorary police officers for the day. Each honorary officer was then presented with a junior police badge and a personalized LAPD ID card by Sergeant Ralph Morales from the Community Relations Section. In return, each officer was given a yellow Sunshine Kids pin from the children. Everyone

was greeted with a fly-over by one of the Department's airships, highlighted by an announcement from the airship's loudspeaker welcoming the honorary LAPD officers to Los Angeles.

At approximately 1030 hours, a radio call was made announcing a Code 3 run, the destination being Raleigh Studios in Hollywood. The

17-car motorcade, escorted by Officer Dan Gregg and 19 WTD motor officers, left the Sheraton Universal Hotel with all 27

children riding in the black-and-white Sergeant cars. As the motorcade slowly proceeded to Raleigh Studios with lights and sirens, it was obvious that spectators along the route were curious as to whom the special passengers were. Meanwhile, at Raleigh Studios, an advance team of LAPD officers and studio employees waited for the motorcade to arrive. Upon arriving, everyone gathered in the Studio theatre, where each Sunshine Kid was given a special gift package put together just for them by the Community Relations Section. Gifts were donated by Chief Bratton, Reserve Officer Roger Andrew (FTHL), the Los Angeles Police Reserve Foundation, Communications

Division (CRU Office), Community Relations Section, the Los Angeles Police Protective League and the Los Angeles Police Federal Credit Union. All present were invited to stay and watch an episode of the TV show *The Closer*, which is filmed at Raleigh Studios. Everyone was then invited for Code 7 with some cast members from *The Closer*.

**RECENT ACTIONS
BY THE
POLICE COMMISSION**

OCTOBER 2: The Commission received a presentation on the status of recruitment efforts. After hearing that there are 4,726 individuals who are going through the screening process, Commissioners asked for a report on how many are at each stage.

OCTOBER 9: The Commission received the Department's examination of the incident in MacArthur Park that occurred on May 1st. Deputy Chief Hillmann and Police Administrator Gerald Chaleff provided a thorough review of the day's events.

OCTOBER 25: All Commissioners attended and participated in Chief Bratton's Reappointment Ceremony.

OCTOBER 30: A verbal status report was presented on personnel investigations of officers involved in the MacArthur Park incident. There are a total of 316 complaints being investigated, and the Department is reviewing all video from the incident and initiating its own complaints.
