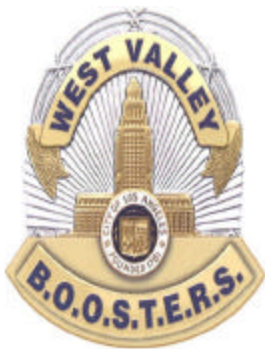

HALLOWEEN SAFETY

Halloween is an exciting night for all the young kids in your neighborhood. It is also a very important time for all parents to be extra vigilant for potential safety hazards. Here are a few pointers, so everyone has a fun night:

PARENTS

- Always escort your children and carry a flashlight
- Always know who is “trick-or-treating” with your kids
- Tell your kids to NEVER enter a strange house on Halloween
- Set a specific time for your children to go out and “trick-or-treat”
- Inspect ALL treats before allowing your children to eat them

CHILDREN

- Walk on the sidewalks, not the street
- Don't go out by yourself
- Don't take shortcuts, especially through alleys
- Obey all traffic signals and look in all directions when crossing the street
- DON'T RUN
- Only “trick-or-treat” at homes with the porch light on

New Online Services for Alarm Systems

The City of Los Angeles requires that all residents and business owners that have an active alarm system have a City permit for their alarm on file with the City of Los Angeles. This permit must be renewed on a yearly basis.

The City now offers residential or commercial alarm system users the ability to manage their alarm permits over the Internet. Users can now register, renew and pay their alarm permit fees over the Internet.

ILLEGAL VENDING IN RESEDA

Illegal food vendors are those vendors that do not obtain a permit from the Department of Environmental Health and operate either openly or covertly in a manner that compromises food safety. These operations are usually found outdoors, in vacant lots, on street corners or roaming door to door through neighborhoods. Sometimes the vending takes place out of the trunk of a car. Health concerns are commonly associated with illegal vendors, such as food stored and prepared directly on the dirt; little or no protection from airborne contaminants; no refrigeration or hot holding equipment; build-up of garbage and food debris on ground; vermin and insects; no way to trace the food back to its original source; and no food safety training for the employees

There is an elevated risk for illness to be transmitted through food sold in this manner. Without bathrooms, the vendors are forced to urinate and defecate on the ground and resume their food preparation activities without washing their hands. Garbage and discarded food are allowed to blow about or accumulate on the ground adding to the sanitation problems generated by this activity.
