This semi-annual public report has been prepared pursuant to Consent Decree paragraph 156. That paragraph states:

*The LAPD shall prepare and publish on its website semiannual public reports required by this paragraph. Such reports shall include aggregate statistics broken down by each LAPD geographic area and for the Operations Headquarters Bureau, and broken down by the race/ethnicity/national origin of the citizens involved, for arrests, information required to be maintained pursuant to paragraphs 104 and 105, and uses of force. Such reports shall include a brief description of each of the following that was completed during that period: (i) report of a specified audit completed, audits completed pursuant to paragraphs 111, 113, 125, 126, 130, 133 and 134, and any significant actions taken as a result of such audits or reports, (ii) a summary of all discipline imposed during the period reported by type of misconduct, broken down by type of discipline, bureau and rank, and (iii) any new policies or changes in policies made by the Department to address the requirements of this Agreement. Such reports shall also include the reports prepared pursuant to paragraphs 173 and 175.*

**II. New Policies/Changes in Policies**

- 1) Consent Decree Paragraph 119 states that the City may establish a tuition reimbursement plan for a reasonable number of officers. On July 1, 2001, the Department issued a Notice to all officers delineating the procedures to participate in the City of Los Angeles College Tuition Reimbursement Program. The program is designed to encourage officers to continue their education.
- 2) Consent Decree Paragraph 109 requires the Department to establish a permanent Department-wide confidential informant database, excluding those informants used by the Department's Anti-Terrorist Division and/or informants used in conjunction with another agency. On September 5, 2001, the Chief of Police issued Special Order # 28 activating the Los Angeles Police Department Confidential Informant Tracking System Database. This Order activated the database and established the requirements and procedures related to its use.
- 3) Consent Decree Paragraphs 104 and 105 require the Department to collect specified data on all traffic and pedestrian stops by November 1, 2001. Prior to November 1, 2001 the Department created a new form for data collection, conducted a pilot program with hand-held electronic devices for data capture and trained Department personnel in the use of the form as well as the Department's Anti-Discrimination Policy. On November 1, 2001 the Department began collecting the required data manually with the new form and is presently reviewing vendor proposals for the future use of hand-held electronic devices.

**III. Audit Summaries**

**CONSENT DECREE AUDIT**  
**OF ARREST, BOOKING, AND CHARGING REPORTS**

January 2002

*On June 15, 2001, the City of Los Angeles and the United States Department of Justice entered into an agreement, Consent Decree, that directed the Los Angeles Police Department (LAPD) to conduct audits of its procedures and operational systems. The LAPD is committed to providing the public with information that facilitates a better understanding of the way in which LAPD officers carry out their law enforcement responsibilities.*

The Consent Decree, paragraph 128, specified that the LAPD shall conduct regular, periodic audits of stratified random samples of Arrest, Booking, and Charging (ABC) Reports. On June 26, 2001, the LAPD completed its first ABC Reports audit. The second ABC Reports audit was completed December 27, 2001. The following is a summary of the second ABC Audit, including findings and recommendations.

**PURPOSE**

*The ABC Audit was conducted to evaluate for the following:*

- Use of canned or boilerplate language;
- Consistency of information;
- Proper articulation of the legal basis for the action;
- Legality and appropriateness of the underlying action;
- Conformance with and adherence to LAPD procedures; and,
- Any other indication that the information was not authentic or correct.

NOTE: For purposes of this audit, the term “charging reports” referred the Department’s Booking Approval, Form 12.31, and is referred to throughout the report as a “Booking Approval form.”

**SUMMARY OF FINDINGS**

*The LAPD review of documents relating to 749 arrest revealed the following discrepancies.*

- Forty-four Arrest Reports, Form 5.2, (6.1%) were approved by a supervisors who printed their name rather than providing a signature, as required.
- Fifteen Booking Approval forms (2.1%) approved by a supervisor who printed their name rather than providing a signature, as required.

- Four arrest reports (0.5%) failed to articulate sufficient facts to support the arrest of the suspect. In three cases, the concerned prosecuting agency declined to file a criminal case, citing lack of probable cause. In the fourth case, the arrestee had been field released from custody. Subsequent to his release, a warrant was issued for his failure to appear in court on the case.<sup>1</sup>
- One arrest report failed to articulate sufficient probable cause for searching the suspect. The search resulted in the recovery of evidence upon which the arrest was based. The City Attorney's Office declined to prosecute the case, citing illegal search.
- One arrest report indicated the officer continued questioning after the arrestee invoked his Miranda rights.
- One arrest report indicated that Miranda was read and an incriminating statement elicited; however, there was no indication that Miranda was waived.

## **RECOMMENDATIONS**

*The audit findings were forwarded to the respective bureau commanding officers for administrative review, the results of which will be retained by AD with the audit. Additionally, it was recommended that bureau commanding officers ensure that the following actions be taken.*

- *Re-emphasize established procedures with Area and Records and Identification personnel regarding the need to reproduce and retain all documentation associated with arrest reports.*
- *Re-emphasize established procedures among Department supervisors pertinent to signature compliance when approving reports.*
- *Evaluate personnel deployment considerations at Records and Identification Division to address the backlog and delay in processing arrest reports.*
- *Ensure officers include in their arrest reports the assignment of the supervisor providing booking approval.*

## **SIGNIFICANT ACTIONS**

*An Intradepartmental Correspondence, Form 15.2, was forwarded to each bureau commanding officer for review and appropriate action. Audit Division has coordinated the effort to ensure that the discrepancies are addressed. As of the date of this report, responses to the 15.2's remain outstanding.*

*As a result of the June 26, 2001 ABC Audit, each Operations Bureau has established an Audit Team to monitor compliance with Consent Decree related issues within their respective commands.*

*Operations West Bureau has increased its oversight in the area of arrest report review and appropriate approval procedures.*

*Operations Central Bureau has added semi-annual training on Narcotics Activities (OO No. 2, 2000), Booking Approval and Inspection of Arrestees (SO No. 10, 2000) and SEU Activation (AO No. 10, 2000).*

*In addition, Management Services Division drafted a Special Order amending the requirement for investigating supervisors who provide booking advice to initial and place their serial number at the conclusion of arrest report narratives.*

**CONSENT DECREE AUDIT**

January 2002

*On June 15, 2001, the City of Los Angeles and the United States Department of Justice entered into an agreement, Consent Decree, that directed the Los Angeles Police Department (LAPD) to conduct audits of its procedures and operational systems. The LAPD is committed to providing the public with information that facilitates a better understanding of the way in which LAPD officers carry out their law enforcement responsibilities.*

The Consent Decree, paragraph 128 specified that the LAPD shall conduct regular, periodic audits of stratified random samples of Use of Force Reports. On October 29, 2001, the LAPD completed its first Use of Force Reports audit. The following is a summary of that audit, including findings and recommendations.

**PURPOSE**

*The Use of Force Reports audit was conducted to evaluate reports for the following:*

- Use of canned or boilerplate language;
- Consistency of information;
- Proper articulation of the legal basis for the action;
- Legality and appropriateness of the underlying action;
- Conformance with, and adherence to LAPD procedures; and,
- Any other indication that the information was not authentic or correct.

The audit also evaluated the supervisory oversight of applicable incident and post-incident review, as mandated in paragraph 128 of the Consent Decree.

**SUMMARY OF FINDINGS**

*The LAPD review of documents relating to 312 Use of Force Reports revealed the following discrepancies.*

***1. Review for Completeness***

- Five Use of Force Reports did not indicate all the types of non-lethal control devices used during the respective use of force incidents.

**2. Review for Canned Language**

- Three primary report narratives contained inappropriate canned/boilerplate language.

- Four Use of Force Reports contained inappropriate canned/boilerplate language by the investigating supervisor, all of which were completed by the same North Hollywood Area sergeant.<sup>2</sup>

**3. Review for Inconsistent Information**

- Fifteen Use of Force Reports contained inconsistencies in the primary report.<sup>3</sup>
- Three Use of Force Reports listed officers who had not used force in the Involved Officers portion of the Use of Force Report.

**4. Review for Legal Basis or Authenticity or Correctness**

- One Use of Force Report did not establish justification for the use of force as prescribed by California Penal Code Section 835(a). The report was adjudicated as Out of Policy during the review process, and a personnel complaint was initiated. This finding is not reflected as a discrepancy because it was addressed appropriately by the respective command.

**5. Review of Underlying Action for Appropriateness, Legality and Conformance with LAPD Policy**

- Two Use of Force Reports indicated that the officer's escalation of force was not commensurate with the suspects' actions. The reports were adjudicated as Out of Policy during the review process and personnel complaints were initiated. These findings are not reflected as discrepancies as they were addressed appropriately by their respective commands.

**6. Review for Supervisory Oversight**

- Sixteen Use of Force Reports indicated that the investigating supervisor participated in, or witnessed the use of force incident. Daily Work Sheets and Watch Commander logs revealed that two of the incidents occurred when only two supervisors were on duty.<sup>4</sup> No mitigating factors were identified for the other fourteen incidents.
- One hundred fifty-seven Use of Force Reports (50%) revealed that the investigating supervisor did not approve all reports related to the respective use of force incident.
- Twenty-seven Use of Force Reports revealed that the investigating supervisor restated details contained in the primary report.

**7. Overall Compliance with Consent Decree Concerns (Paragraph 128)**

- Sixteen of the 312 Use of Force Reports (5%) contained discrepancies that were determined to be of *Paramount* significance. All of these discrepancies resulted from supervisors investigating a Use of Force incident that they either participated in or witnessed.

**RECOMMENDATIONS**

*The audit findings were forwarded to the respective bureau commanding officers for administrative review, the results of which will be retained by Audit Division with the audit. Additionally, it was recommended that the bureau commanding officers ensure that the following actions be taken.*

- 1. Publish a Department directive that clarifies when the application of a Rip Hobble device becomes a separate reportable use of force.*
- 2. Emphasize the following issues during the use of force segments of Supervisor and Watch Commander Schools.*
  - *Supervisory responsibility for ensuring that all related reports are consistent and completed according to established guidelines;*
  - *Special Order 27, 2001, which mandates that the investigating supervisor shall not investigate any use of force incident in which they either participated or witnessed; and*
    - *Special Order 27, 2001, which mandates that the investigative supervisor shall not go “end of watch” until he or she has received and signed all reports related to the use of force incident.*

**SIGNIFICANT ACTIONS**

*Intradepartmental Correspondence, Forms 15.2 were forwarded to each bureau commanding officer for review and appropriate action. Audit Division has coordinated the effort to ensure that the discrepancies are addressed. As of the date of this report, responses to the 15.2's remain outstanding.*

*Five Consent Decree-mandated audits are scheduled for the third quarter of Fiscal Year 2001-2002. The scope of each audit is described below.*

**SEARCH WARRANTS AND AFFIDAVITS (CDTF #00-033)**

The audit is required by Consent Decree paragraph 128(1) and is assigned to Audit Division (AD). Search Warrants and Affidavits will be reviewed to ensure completeness of information and to evaluate the following:

- Use of canned or boilerplate language;
- Consistency of information;
- Proper articulation of the legal basis for the action;
- Legality and appropriateness of the underlying action;
- Conformance with and adherence to LAPD procedures; and,
- Any other indication that the information was not authentic or correct.

**INFORMANT CONTROL PACKAGES (CDTF #00-033)**

The audit is required by Consent Decree paragraph 128(5) and is assigned to Criminal Intelligence Group (CIG). The audit has been postponed until the fourth quarter to allow sufficient time for implementation and evaluation of the procedures set forth in the new Informant Manual.

**USE OF FORCE INVESTIGATIONS (CATEGORICAL) (CDTF # 00-004)**

The audit is required by Consent Decree paragraph 129(i) and is assigned to AD. The audit will be constructed to verify compliance with the requirements concerning categorical uses of force as described in paragraphs 55-69.

**MOTOR VEHICLE AND PEDESTRIAN STOPS (CDTF # 00-018)**

The audit is required by Consent Decree paragraph 128(4) and is assigned to Management Services Division (MSD). Consent Decree paragraphs 104 and 105 require that specific information be recorded by police officers who stop motor vehicles and pedestrians. According to MSD, the initial audit will measure if the forms are being completed when required.

**EMPLOYEE FINANCIAL RECORDS (CDTF #00-050)**

The audit is described in Consent Decree paragraph 132 and is assigned to CIG. The audit has been postponed until meet and confer issues are addressed at which time the audit will be rescheduled.
